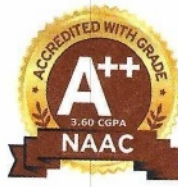

I am directed to inform you that the Hon'ble Vice-Chancellor, Central Sanskrit University, Delhi is pleased to grant affiliation to your institution, for the session 2026-27 purely on temporary & Ad-hoc basis, for the following courses:-

1. Shastri (Sahitya)

This affiliation can be withdrawn at any time if the CSU is not satisfied with the performance/working of your institution as per the terms and conditions prescribed from time to time by the Central Sanskrit University. You are therefore, requested to kindly ensure that your institution is functioning in accordance with the syllabi of the CSU and strictly following all rules, regulations & instructions, failing with the affiliation granted will withdrawn/cancelled and CSU shall not be liable for any consequences thereof. The CSU reserves the right for inspecting your institution at any time and withdraw affiliation even during the academic session if the institution's activities/functioning found against the guidelines applicable to the institutions affiliated to Central Sanskrit University, Delhi.

The renewal of this affiliation is subject to the institute maintaining a minimum enrollment of 20 students. Additionally, the institute may not be designated as an examination center for its own students. However, to qualify as an examination center, the institute must have a minimum of 15 students.

The affiliation is only for study purpose. Central Sanskrit University will not provide any kind of grant and infrastructure.
